

Our external partner Hellios Information will contact you with details on how to complete the JOSCAR Zero questionnaire. JOSCAR Zero is an additional process to JOSCAR and requests different information.

Frequently Asked Questions

Why have I been asked to join JOSCAR Zero, I am already on JOSCAR?

- JOSCAR is used as a tool for the Aerospace and Defence industry to store compliance information, helping determine if a supplier is "ready for business."
- JOSCAR Zero is a separate tool with a smaller question set for accurate carbon reporting, providing you and your customer with the tools to reduce. Aerospace & Defence organisations are using JOSCAR Zero to reduce Scope 3 emissions, supporting Net Zero goals.

What is the role of Hellios Information?

- Hellios Information is a UK-based organisation. The team has extensive experience in the collection and maintenance of supplier data and so Leonardo has appointed Hellios Information to collect and process supplier data on our behalf.
- Hellios Information does not assess supplier suitability for compliance approval, this
 decision always remains with each of the buying organisations.

What areas does the questionnaire cover?

• You will be required to submit site level consumption data for Scopes 1 and 2, along with any Scope 3 categories you've calculated at the site level. On average, suppliers are typically required to respond to 30 questions.

Will my competitors have access to the information we provide?

• Other suppliers will not have access to the information you provide. It is only available to the buying organisations using JOSCAR Zero. Each buying organisation has signed confidentiality agreements with Hellios Information.
