What is JOSCAR?

The Joint Supply Chain Accreditation Register (JOSCAR) is a collaborative platform used by major defence, aerospace, and security companies to simplify and standardise supplier assurance and compliance processes.

We have partnered with Hellios Information Ltd to manage the collection and validation of supplier information, reducing administrative overhead and duplication across the supply chain.

As a key or prospective supplier to Martin-Baker Aircraft Co. Ltd, you're invited to complete the JOSCAR registration process. This ensures your company meets our evolving compliance and qualification standards.

- ▼ Single Profile for Multiple Buyers: Complete one profile shared with other major buying organisations (e.g. MoD, BAE Systems, MBDA, Leonardo).
- ▼ Reduced Duplication: No need to repeat compliance submissions for different companies.
- ▼ Tailored Process: Questions adapted to the products/services your company provides.
- ▼ Ongoing Access: Update your compliance status year-round via your online profile.

Registration Process



Stage 1 Basic Registration

- ▼ Complete an initial online questionnaire (free, under 60 minutes).
- ▼ The questionnaire covers a broad range of topics including but not limited to; insurances, ISO standards, quality, health & safety, environment, business continuity, import/export, IT and data privacy.
- ▼ Determines whether further qualification is needed.

Stage 2 Full Qualification

- ▼ For higher-risk goods/services.
- ▼ Involves detailed evidence submission and validation.
- ▼ Fees may apply, depending on your annual revenue and trade body affiliations*.
- ▼ SMEs and ADS members may qualify for discounted or free access.

Validity

JOSCAR qualification is valid for one year. Hellios will issue renewal reminders.

Confidentiality

Only prime contractors you have given permission to, can view your data. Other competitors/suppliers cannot.

Support

Hellios provides full guidance throughout the process.

Frequently Asked Questions

How does JOSCAR keep my data secure?

The community adheres to strict security standards to protect your information. Hellios Information is certified to ISO27001 and Cyber Essentials Plus, the National Cyber Security Centre standard backed by the UK Government.

When should I start the process?

We recommend acting as soon as possible because it may take some time to complete the new process and address any compliance gaps that may be found.

What happens if you dont register?

Failure to complete JOSCAR may delay procurement decisions and limit your opportunities with Martin-Baker and other defence companies. Registration ensures streamlined engagement and ongoing qualification.

How long will have to complete this?

All suppliers are provided 8 weeks to gather the information required. However, there are circumstances where we may request a shorter completion timeframe. Suppliers will be fully supported by Hellios Information throughout.
